Public Official: \$125 (\$90 annual dues plus a one-time \$35 enrollment fee for new members) Offices of the Rocky River Mayor, Municipal Directors, Council Members, City and Court employees, Rocky River public school executives and administrators, elected members of the Board of Education, and all other public officials serving the Rocky River area. One representative per membership.
