RESTAURANTS & FOOD PROVIDERS

Restaurants exhibiting in Taste of River sell tasting portions of their restaurant's featured food. The tasting portions will have a selling price, set by that exhibitor, in increments of \$1.00. The Taste of River Committee will be selling food tasting tickets for \$1.00 each at the entrance. Food is purchased from each exhibitor with tickets, cash is not to be accepted or exchanged at food exhibitor booths.

- Exhibitors will receive 50% of the proceeds of each ticket submitted at the end of the event.
- You are encouraged to offer tasting items that are unique to your establishment.
- Tables (8' x 30") will be provided: one on the aisle for selling and one behind you for prep/storage.
- You are responsible for table covers and signage on your table.
- You are responsible for providing your own serving and dining supplies.
- Shared access to the kitchen at the Don Umerley Civic Center is available.
- Bring advertising materials (brochures, menus, business cards, etc.) for distribution at your table.

RETAILERS

Exhibitors in Buy River may sell products, with a vendor license.

- At least one table (8' x 30") will be provided. Details of your space will be finalized once the floorplan is complete.
- You are responsible for table covers and signage on your table.
- Bring advertising materials (brochures, coupons, business cards, etc.) for distribution at your table.
- It is your responsibility to ensure you have or obtain an Ohio Transient Vendor's License prior to Buy River. If you need a Transient Vendor's License, contact the Ohio Department of Taxation at 888.405.4039 or 216.787.3122 or online at www.tax.ohio.gov

- Restaurants not prepared to serve food by 11:45am when the health department inspector arrives may not be permitted to exhibit and the registration fee will not be refunded.
- Tear down prior to 3:00pm is prohibited.
- Exhibitors are responsible for table covers and signage on your table.
- Restaurants may collect tickets only and must turn them in at the end of the event. 50% of ticket proceeds will be returned.
- Registration fees are non-refundable.

This contract will govern the conduct of the parties hereto from move-in, event day and move-out, except in the event of an unavoidable emergency necessitating the cancellation or postponement of the event. In such event, this agreement shall terminate immediately, both parties hereto waiving any claim for damages or compensation.
